

# STRONG WORKFORCE INSTITUTE: RETHINKING THE STUDENT EXPERIENCE FOR RETENTION AND SUCCESS

An institute hosted by the San Diego-Imperial Regional Consortium

## BACKGROUND

The SWP Institute is a new professional learning opportunity for faculty. SWP Institute participants will:

- Learn more about their students, specifically about their retention, persistence, and success outcomes;
- Apply the knowledge gained from completing an investigative project to better connect with students; and
- Develop an action plan to implement their ideas in the classroom

Between Spring 2020 and Fall 2020, faculty will attend two in-person learning events and conduct a project (investigative research and action plan) in collaboration with researchers at their campuses. Faculty will receive a \$2,000 stipend for attending both events and completing the project. Funding will be available through a Request for Applications (RFA) to support and build the research capacity at each campus.

## STATUS REPORT

**Before designing the specific details of the SWP Institute, the Regional Consortium presented the concept to, and received feedback from, key stakeholders:** San Diego Imperial Counties Community Colleges Association (SDICCCA), Regional Oversight Committee (ROC), Workforce Development Council (WDC), Deans Council, Public Information Officers (PIOs), Data & Research Committee, and institutional researchers.

**There are 16 project team members and 20 advisory group members, with representation from each college in the region, including faculty and researchers.** The project team is responsible for designing the details of the SWP Institute and the advisory group is responsible for providing feedback on the design.

**To determine what researchers need to prepare for the institute, the project team must finalize the investigative project first.** The project design will determine what will be requested of researchers in the RFA. The project team had a kickoff meeting on June 21 and worked on the investigative project design since then. A first draft is expected to be completed by August 14, 2019.

**The first in-person (kickoff) event was originally scheduled for September 27, 2019; however, to give researchers ample time to prepare for the SWP Institute, the kickoff event will be rescheduled to February 2020.**
