- Enrollments More emphasis on noncredit programs and more coordination with departments that have credit programs
 - New noncredit certificate programs created for: English and mathematics, the construction industry, pursing and paramedic training, and drones
 - Five new noncredit certificate programs created to serve non-native speakers of English
 - Mirrored noncredit courses developed to serve older adults



Palomar College

- Assessment Increased investment in assessment to determine progress toward noncredit milestone outcomes measures
 - An ESL instructor is dedicated to building Integrated Education and Training programs and has implemented the use of COAAP (Civic Objective and Additional Assessment Plan) measures to determine progress toward milestones for students
 - Milestones are assessed and can result in additional payment points through WIOA II



Palomar College

- Data Emphasis on accuracy and alignment
 - Using CASAS pre and post assessments to align with our adult education partners.
 - Consortium data manager works with Information Services and Institutional Research and Planning to track student movement among consortium member districts
- Transitions Added mirrored noncredit programs
 - Concurrent credit/noncredit courses have been established
 - A noncredit counselor supports both our noncredit students and assists students transitioning from the adult schools to Palomar College


