3. Curriculum Institute Update: A. Taccone reminded the group that the Curriculum Institute will be held on Friday, February 26, 2021 from 9:00am- 12:00pm. An outlook invitation has been sent out to the regional Career Education Deans; they are asked to share it with whomever they think would benefit from the information.

4. Early College Credit Efforts and Handbook: A. Perman presented an update on two priority projects from the Career Pathways workgroup.

- 1. Program Finder
  - a. Launching in March 2021 March 16th demo of live site
  - b. WG focused on informing rollout of user group workshops
- 2. Early College Credit
  - a. Refinement of focus and goals
  - b. Regional Handbook Development and Common Definitions
    - i. Purpose: Support a Student-Centered, Equity-Based Approach to Early College Credit for Career Pathway Completion
    - WG1 Project Goal: To produce a Regional Handbook intended to support regional K-12 school, adult education, and community college practitioners in working together to build meaningful early college credit (ECC) opportunities that promote career pathway completion and close equity gaps for students in San Diego and Imperial Counties.
  - c. **Next Steps:** WG1 members are providing final feedback on current working draft documents by the end of the month; we will then revise them and distribute for a more expanded round of feedback.

5. WBL Professional Development: K. McMackin provided an update on the status of the WBL professional development opportunity. He reminded the group that the focus is to provide faculty with a deeper understanding of the work-based learning continuum so that they can enrich their courses and support students by broadening their WBL opportunities, as well as to prepare them for the new SG21 MIS data point. The initial group of participating faculty members met and reviewed the draft course outline of record developed by the region. Because of the similarities between that and the WBL professional development work already being done at Southwestern, collaboration is occurring to tailor the information to a regional audience. The goal is to offer this opportunity in summer or fall 2021.

6. Collaborative Curriculum Development: D. Brown shared that there has been a request resulting from some of the sector RFA investment meetings for assistance in developing curriculum for new programs. Because colleges cannot hire their own faculty due to contracts restrictions, and because the region cannot pay for curriculum development, there is a need for additional resources. J. Lewis noted that the Regional Directors have been extremely helpful in identifying support thus far. D. Brown asked the colleges to reach out to the region if they need this type of assistance.

7. Flex Credit/Salary Advancement Regional PD: D. Brown proposed the idea of providing flex credit and salary advancement as a way to incentivize faculty to participate in professional development opportunities. The deans were in support of this idea so she will move forward with compiling more information.

8. NOVA reporting and Round 3 close out: S. Cox shared that currently, reporting for round 3 is roughly \$1M short of where it needs to be. She stated that she will be looking closely at the colleges that are significantly behind in their spending and will modify their contracts in order to reallocate those funds. She also shared that all of the Round 5 projects have been entered into Nova.
