

K14 Career Pathways workgroup meeting summary 6.21.22

K14 Career Pathways planning:

- This is our final meeting of the fiscal year. We're proud to review the K14 Career Pathways workgroup [2021-2022 summary](#) that displayed the great work we have accomplished.
- We discussed the K14 Career Pathways workgroup [2022-2023 preliminary planning goals and priority projects](#) and received positive feedback, which included exploring opportunities to support college efforts by increasing faculty awareness and engagement (now added to goal #3, e) and support for the relaunch of a new and improved college, K12 and adult education program finder tool on careered.org. We will revisit the 2022-2023 goals and priority projects at our meeting in September.

Options After High School survey:

- The group reviewed the recommendations for [Colleges](#), [K12 Districts](#), and [K12 Sites](#) Level Interventions. These intervention documents are a result of comments from stakeholders in the field and are not meant to duplicate efforts at the local high school and college level, but rather support, fill in gaps and leverage what the high schools and colleges are already doing.
- An overview of the new and exciting [K12 district-level regional dashboard](#) was shared. The dashboard allows you to look at data from multiple perspectives - by grade, career area, or any number of combinations of factors. A brief guidance document with prompts is provided to help your district explore the data.

Career Pathways Partnership updates:

- Adult Ed/Noncredit – we have added an additional person from each consortium to the Data Repository CoP and the user guidance document is up to date. This fall, horizontal alignment efforts and adult ed pathway integration into the colleges and K12’s will be a focus.
- K14 (Articulation Credit by Exam CoP) – we are still working on compiling regional articulation data. Over the summer, we will be asking college and K12 partners for specific data to be used in Phase 2 of our articulation work in collecting baseline data, including demographic and completion information.
- MS/HS Engagement (Outreach CoP) – currently creating a pilot series of events (happening in the Fall) to showcase college career education programs to high school students across the region, by pathways.
- Credit for Prior Learning (CPL) – a CPL training course, developed by college practitioners this past winter and spring, is being created in the Vision Resource Center for launch in the fall and CPL implementation efforts are happening at the colleges across the region.
- Rising Scholars – a regional Rising Scholars video (funded by the Southwestern College Foundation) features members of the college’s professional team and Rising Scholars students that share their journey and how the community college has impacted them personally.
