Workgroup Overview & 2022-23 Focus Areas:

- We reviewed the [2021-2022 summary](#) and [2022-2023 preliminary planning goals and priority projects](#). Members were asked to give feedback about the goals, to think about their contributions to this work, and what is most meaningful to the group.

Workgroup membership:

Regional Consortium Mission, Vision and Goals:

- Danene Brown, Regional Consortium Chair, presented a draft of the Regional Consortium mission, vision, and goals.
- A [Jamboard](#) activity took place asking each member to give comments/suggestions about how each K14 workgroup goal aligns with the regional goals. Members were asked to reflect on how our workgroup supports these goals and/or lacks the support of these goals. This feedback will be used for future goal planning.

K14 Workgroup Presentation Topics Discussion:

- The Oct-June workgroup monthly meeting schedule was reviewed. The plan is to identify discussion topics for each meeting ahead of time. A [Jamboard](#) activity took place asking members to add their ideas for presenter suggestions and/or partnership highlights for each meeting topic. Members were also asked to include additional meeting topics.
- The monthly workgroup topic meeting schedule will be reviewed at the October 18 meeting.

Early College Credit Updates:

- Mallory Stevens, Early College Credit & Transitions Specialist, Consultant for the Regional Consortium, gave a sneak peek of the regional dual enrollment and early college credit [webpage](#). Mallory continues to collect topics, feedback, and resources to build this webpage.

Career Pathways Partnership updates:

- Adult Ed/Noncredit – focus is to continue work on the adult ed/noncredit data repository tool that was created to interface with the Program Finder tool. Similar career training programs across the regions are being analyzed in an effort to achieve horizontal alignment. The data repository CoP and adult ed/noncredit workgroups have merged, to streamline and increase collaboration.
- K14 (Articulation Credit by Exam CoP) – efforts are being made to achieve agreed upon regional recommendations around Administrative Procedures (AP's) and Board Policies (BP's) related to articulation. The goal is to achieve consistency and have student-centered language across the region. About 56 articulation staff responded to a statewide survey. Highlights and a summary of this survey will be provided next month. The Phase 2 data collection project is in process. About 645 individual college courses are tied to active articulation agreements in our region. The next phase is to find out student numbers. The goal is to provide a regional data dashboard this spring. Moving forward, we will do this update annually.
- MS/HS Engagement (Outreach CoP) – the MS/HS Engagement advisory will be meeting this fall, the date is TBD. The Outreach CoP is currently creating a pilot, Map Your Path, where the focus is college outreach to high schools by pathway, not necessarily by geography. The outreach staff plans to showcase career education programs to juniors and seniors at high schools with lower college-going rates this November.
