Regional K-14 Career Pathways Workgroup focuses primarily on middle school/high school partnerships and collaborations to transition to college and early college credit initiatives. Primary question and topics of interest:

- What data you have and are using and what challenges are you facing looking at these transitions?
- High school to College Pipeline Reports
- Pathways to Retention
- Dual Enrollment Transitions

Palomar collects data and produces reports on findings.

MiraCosta has a navigation dashboard for enrollees that track the following:

- Concurrently Enrolled Students by Course
- Dual Enrollment
- Articulated High School Courses
- High School Capture Rate
- MiraCosta Promise (Incoming)

SDCCE looks at all the students enrolled in courses on the way to receiving college credit and looks at gaps between students with the grades and students who receive college credit.

Goal

- Overview of the regional recommendation process

- A rubric framework for the COE's program endorsement or non-endorsement
- Explanation of endorsement or non-endorsement

Regional Recommendation Process

- Program Idea/Concept Development – Idea for a new program or modifying an existing program
- LMI Request and Supply Gap Analysis – Request a report on LMI, and COE provides endorsement or non-endorsement
- Regional Discussion about Program Intent – The region discusses program intent, COE report and endorsement or non-endorsement
- Official Regional Program Recommendation – After a discussion is held for each program under review, a final regional recommendation is provided

The COE evaluates available LMI to determine program endorsement or non-endorsement such as supply gap, wages, annual job openings, and institutions that train for occupations. Additional LMI may also be considered

Result could be one of three options:

- Proceed with New Program (Support Modification)
- Proceed with Caution (Support Modification)
- Do Not Proceed with New Program (COE Defers to the Region)
