4. The Labor Market – Economic Recovery: T. Ngo Bartel shared how labor market research done by the

Center of Excellence (CoE) is validated by employers and used by the Regional Directors to construct the sector profile and strategy. She explained that this information is used to create Request for Applications (RFAs) which college can use to apply for funding to help them align their programs with labor market data.

- Cybersecurity: D. Rinehart presented the sector profile and strategic recommendations for the Cybersecurity subsector in San Diego and Imperial Counties. He provided a description of the Cybersecurity subsector, the methodology behind the subsector analysis, Cybersecurity certifications, labor market information for the subsector, regional trends for the subsector, and specific recommendations to the colleges.
