- S. Wyche shared that through experience, Palomar College discovered there are two versions of the Perkins Audits. Provides warning to verify which audit is being completed so colleges can make the correct preparations.
- L. Wisdom request feedback on K-12 and community colleges collaborations. Possibly start Spring 2024, having each college host their K-12 administrators, teachers, and counselors. Sharing highlights on the great things happening with their programs, the provide program tours, and have deep conversations about how to better collaborate in the future. L.
