

## K14 Career Pathways workgroup meeting summary 6.27.23

#### Workgroup Update:

Our June meeting was focused on equity, a recap of our work in FY 22-23 and draft goals for FY 23-24, and updates. Suzanne Sebring provided an update on the development of the regional Program Finder tool. The launch will occur this summer with more details, links, and a demonstration shared at our first fall meeting on September 19th.

#### Equity:

- Suzanne Sebring introduced Ben Gamboa, Associate Dean at MiraCosta College, who shared the [Black Student Success presentation](#) based on the [Regional Black Student Equity Report](#), followed by Q&A.
- Al Love and Margie De Ruyter shared the work that San Diego County Office of Education (SDCOE) has been doing around the [Equity Blueprint](#).

#### Recap of FY 22-23 and setting the stage for FY 23-24:

- Amertah Perman walked the workgroup through the [K14 Career Pathways WG Summary FY 22-23](#), which lists the overarching regional career pathways purpose, where the workgroup fits in to the region's Student's Road to Career Success, as well as workgroup goals, priority projects identified and accomplishments/updates on the activities conducted to support the priority projects.
- To set the stage for FY 23-24, Amertah shared the [K14 Career Pathways WG Draft Goals FY 23-24](#) and asked the group to submit any feedback by **July 31, 2023**.

#### Updates: Career Pathways Partnership:

- **Adult Ed/Noncredit** - Suzanne Sebring shared that the new Adult Ed/Noncredit chairs for FY 23-24 are Kelly Henwood, San Diego College of Continuing Education; and Ute Maschke, East Regional Adult Education. Meetings of this workgroup are complete for this fiscal year and will begin again in the fall. Horizontal alignment of programs will continue following the summer break. The California Adult Education Program (CAEP) Summit will be held in person this year at the Hilton University City from October 24-26, 2023. - **K14 (Articulation Credit by Exam and Dual Enrollment CoP)**: Leslie Wisdom updated the group indicating that those that had submitted complete applications to the CDE for the Dual Enrollment grants should be receiving their GAN's, if they haven't already. Because all funds were not allocated, there will be another round of funding. The RFA to support Community College dual enrollment has not yet been released. The data project is still underway. This will continue into the next fiscal year and there may be some additional support for those K12 and CC institutions where the data collection and sharing was a major struggle.
