1. Welcome & Introductions

- J. Lewis introduced J. Kropp as the new Workforce Director at Southwestern College.

5. Border Region Talent Pipeline/K16 Collaborative [Update](#)

- C. Jensen shared an update on the 23-24 Undergraduate Student Internship Program
 - The goal of the internship program is to expand access to high-wage, high-demand careers for diverse and underrepresented talent, helping to build a diverse local talent pipeline to meet workforce needs.
 - Company data showed 128 applied (110 SD & 18 IC) & 104 hosted (91 SD & 13 IC)
 - 400 total opportunities students could “apply” for: 140 unique positions in business (69 in computing, 48 in engineering).
 - Student data showed 1,254 applied (27% CC), 915 were verified and 385 were hired (30% CC).
 - Community College breakdown: 342 students applied, 259 students verified & 107 hired.
 - Applications to become a verified program for 2025 are due by the end of September. If you were already verified in 2024, reapplication is not required.
- Education Work Experience Student
 - Interns are working in person at K12 districts, LEAs and elementary middle or high school during both the fall and spring semester.
 - Interns earn \$20/hour for up to 290 hours
 - 11 districts are participating
 - 64 students applied, 40 students were hired
 - Additional round of student placements for the Spring Semester only
 - Applications open October 4-November 3, 2024
- Request a follow-up meeting to discuss strategies for improving Community College hiring rates for the upcoming year
- Sharing of best practices
 - Who is applying? Reminder underrepresented students receive additional points in process
 - Work with research office to create a targeted list for faculty to reach out to specific

students

- Use the Career Centers to work with the students on resume & application skills
 - C. Jensen shared they would be sending out a survey to students who participated asking if they use any Career Center services when applying.

6. Apprenticeship [Update](#)

- J. Stark shared SDI RC was awarded \$750,000 grant over 3 years from the Irvine Foundation to strengthen our regional efforts around new apprenticeship development.
 - This funding will allow the hiring an apprenticeship employer liaison & formalized structure for a regional apprenticeship hub to be created.
- Congratulations to SD Miramar and SDCCE for being awarded the [COYA grant](#).
- Congratulations to MiraCosta on their Strong Workforce Program Sector Award that includes development of a new pharmacy technician apprenticeship program in partnership with CVS.
- November 17-23 National Apprenticeship Week
 - The region will be organizing professional development sessions focused on creating connections to registered apprenticeships via pre-apprenticeship programs.
