  - The SDI RC has launched a new newsletter called *The Consortium Connect*. Please provide your feedback and let us know if you haven't received it.
  - Asked group on adapting the WBL Professional Development Course for non-faculty members
    - Yes, but please be mindful of the costs, as budget cuts may limit the colleges' ability to fully support this area.
  - D. Brown and K. McMackin met with <u>Graduation Alliance</u>, which specializes in enrollment optimization and engaging with students who are enrolled but not attending or have dropped out. Their services include concierge support, case management, and student check-ins (\$25 per student for check-ins and \$60 per student for coaching, with a minimum of 1,000 students).
    - Currently, there is no regional funding available, but if a college is interested in meeting with them, please reach out.
  - All RFAs for Rd8 will close at the end of October, so please submit application via GroupTrail by October 31, 2024.
    - Please let the region know if you are no longer planning to submit an RFA, to allow those funds to be reallocated.
