 - Adult Learner Advisory
 - The Deans requested that the Adult Learner Advisory Committee begin meeting to help inform the upcoming Round 10 Adult Learner Institute RFA.
 - T. Ngo Bartel reminded the group that this is an advisory body specifically to inform the Round 10 Adult Learner Institute RFA.
 - A request was made to remove “Committee” from the title and refer to the group as the Adult Learner Advisory.
 - Chancellor’s Office Vision 2030 Regional Convening

- Community Forums Update
 - An update was provided on the Career Education Community Forums. The final forum was held Thursday, December 11 at Grossmont College. A total of 272 participants attended across the seven forums.
 - Appreciation was expressed to the Deans for leading the invitations and supporting re-engagement with community partners.
- Adult Learner Study & Upcoming Presentations
 - The [Adult Learner Study](#) was released last week. The findings will be presented at the [Workforce Development Council \(WDC\) on Friday, November 21](#). Members were encouraged to attend.
 - Panelists will include Alex Berry (Mesa), Candace Rose (Palomar), and Randy Beach

- (Southwestern).
 - An abbreviated version of the presentation will also be provided at the ROC meeting on Wednesday, November 19 at 3:30 pm.
- "Meet Our Grads" Digital Marketing Campaign
 - The region is launching a new digital marketing campaign, "Meet Our Grads," in response to a funder request. The campaign will feature 1–2 minute videos highlighting adult-learner graduates, their current careers, and how their education contributed to their success.
 - Videos will be formatted for Instagram and TikTok.
 - College PIOs will be notified separately.
 - A companion "Meet Our Students" series will also feature current students.

7. Hot Topic Discussions

- Community Education/Contract Education
 - J. Lewis led a discussion on current college practices in this area and whether programs are self-supporting in accordance with Education Code.
 - Palomar College
 - N. Roe reported that Palomar does not currently have dedicated staff for this work but is interested in program growth and is exploring a new registration system. The function is housed within Continuing Education; however, staffing has not been assigned, and individual departments are managing components of the work. The college is moving toward industry-recognized certificates.
 - A suggestion was made to consider forming a CoP.
 - San Diego City College
 - J. Lopez noted that the college is interested in being more responsive to partners; however, bandwidth, specifically limited staffing and funding, is the primary barrier.
 - There is interest in replicating successful self-supporting models.
 - MiraCosta College
 - B. Gamboa shared that colleges are leveraging ETP models (e.g., Shasta and San Bernardino) and expressed interest in learning how to implement ETP more broadly to build capacity.
 - Cuyamaca College
 - G. Dowden reported that not-for-credit is not currently a priority and contract education activity is limited.
 - J. Ayala echoed Grossmont was the same.
 - SDCCD
 - A. Perman shared that SDCCD does not have a not-for-credit branch. ETI runs Contact Training under the SD Continuing Education Foundation, with limited partnership across the colleges.
 - Southwestern College
 - J. Lewis reported that Southwestern operates a model similar to MiraCosta's, with a full-time staff member dedicated to the program. The program is currently self-supporting following an initial one-year SWP investment to support sustainability.
 - The college is working with SDWP on ETPL
 - Also exploring the establishment of a Prometric Test Center that would be housed in this department.

8. Roundtable

- A. Perman highlighted the success of SDCCD's first Annual WBL Summit and expressed appreciation for the region's support.
- A. Perman shared that new guidance has been released for AB 232 and reminded the group to incorporate it into their SWP project plans.
- J. Lopez shared an invite to the group to attend the [Fall 2025 Apprenticeship Forum](#) taking place on December 4 @ San Diego City College.
