California Adult Education Program (CAEP)

- November 2025

English Language Learner (ELL) Healthcare Pathways

- Final Report for Round One funding cycle is now available in NOVA. In light of the delayed publication of this final report, the Chancellor's Office has extended the deadline for Round One Final Report from September 30, 2025, to Friday, October 31, 2025 by 5:00 pm.

The Final report is cumulative to wrap up the entirety of Round One and has questions for both Consortia and participating Members. Economic and Workforce Development (EWD)

The Industry-Driven Regional Collaboration (IDRC) Grant facesheets are currently progressing through the Chancellor's Office internal approval process and are expected to be delivered to the field within the next 2–3 weeks.

Recognizing that colleges and districts must present facesheets to their Boards for approval, staff will be emailing awardees *draft versions* of the facesheet and scope of work. These draft facesheets **do not need to be signed or returned to the Chancellor's Office**, as they are provided solely for use in your local Board approval process to reflect an *intent to award*.

Districts may begin incurring allowable expenses, including salary and benefits, aligned with their approved project budgets. However, please note that funds cannot be disbursed until the facesheet is fully executed. This means your college or district will need to frontload costs temporarily and then request reimbursement once all approvals are complete. Funding is secure, and the paperwork is actively moving through the state's internal approval process.

Additionally, staff will be contacting districts to verify or update contact information for the designated Project Director overseeing the IDRC project at your campus. Please note that if a college or district submitted two proposals listing the same individual as Project Director for both awards, a new Project Director must be designated for one of the projects, as one individual cannot oversee both grants.

Employer Engagement:

- The final narrative questions have been added into NOVA for both Perkins V and Employer Engagement (EWD) within the Quarter 4 respective reporting sections. AB 323 Direct Student Support

- Under AB 323, colleges may use SWP funds to provide direct financial support for paid WBL experiences, including apprenticeships, internships, externships, and student-run enterprises. These opportunities are intended to improve employability and employment outcomes for students enrolled in SWP. Colleges are encouraged to design programs that align with regional labor market needs and to prioritize equitable access for traditionally underrepresented and economically disadvantaged students.
